ATTRIBUTES

- ◆ The candidate is someone who exhibits leadership qualities and has made positive impact to his/her organization
- ◆ Is actively involved in pharmacy-related projects and activities.
- ◆ Significant contributions to the pharmacy profession

NOMINATION

- ◆ A nomination must be made on the prescribed Nomination Form
- ◆ The candidate must be nominated by a member of the PSS.
- ◆ The candidate must be a member of the PSS and preferably have at least three years of working experience.
- ◆ The candidate must be from non- community and non- hospital sector (e.g. sales & marketing, regulatory, R&D, manufacturing etc)
- ◆ Submit a brief CV of the candidate and highlighting his/her accomplishment
- ◆ Nominations must be submitted on official forms by **22 September 2008**.

SELECTION

 - ◆ The ASC reserves the right to reject any nomination without providing any reason
 - ◆ The ASC will select the winner based on the attributes prescribed above
 - ◆ In the event that no winner is selected by the ASC, this prestigious award will not be presented for that particular year
 - ◆ Nominees will be judged on the following aspects:
- ◆ Professional Contribution
- ◆ Professionalism at work
- ◆ Leadership & Vision

THE WINNER

- ◆ The winner would receive a certificate and prize money of \$1000
