### **OBJECTIVES**

- ◆ To give due recognition to pharmacists who have excelled in the area of hospital pharmacy
- ◆ To identify leaders / role models in this area
- ◆ To encourage healthy competition amongst pharmacists
- ◆ To encourage and promote excellence in the pharmacy profession

### **ATTRIBUTES**

- ◆ The candidate is someone who mentors junior pharmacists and staff and exhibits leadership qualities
- ◆ Is actively involved in hospital-based practice research / quality improvement related projects. Publications are a bonus.
- ◆ Has contributed significantly to his / her/ organization in the area of pharmacy practice
- ◆ Significant contributions to the PSS is a bonus

### **NOMINATION**

- ◆ A nomination must be made on the prescribed Nomination Form together with a Curriculum Vitae of nominee
- ◆ The candidate must be nominated by a member of the PSS, preferably from the hospital sector. (including Pharmacists in Polyclinic environment)
- ◆ The candidate must be a member of the PSS and must have at least three years of working experience.
- ◆ Submit a letter of support / endorsement from his senior, supervisor or manager
- ◆ Nominations must be submitted on official forms by **31<sup>st</sup> July 2007**.
- ◆ Completed forms with accompanying documentation should be forwarded to:

### **SELECTION**

- ◆ The Award Selection Committee (ASC) will select a winner from the nominees and its decisions are final
- ◆ ASC to be determined by the sponsor and the current PSS Council and may include the President, Vice-President, Ex-officio of Community Chapter and PSS Advisors.
  - ◆ The ASC reserves the right to reject any nomination without providing any reason
  - ◆ The ASC will select the winner based on the attributes prescribed above
  - ◆ In the event that no winner is selected by the ASC, this prestigious award will not be presented for that particular year
  - ◆ Nominees will be judged on the following aspects:
- ◆ Professional Contribution
- ◆ Professionalism at work
- ◆ Leadership
- ◆ Vision of Pharmacy Practice

### **THE WINNER**

- ◆ The winner would receive a certificate and prize money of \$1000
- ◆ The winner must deliver an acceptance speech of about 5 minutes
- ◆ The winner must be agreeable to be an “Ambassador” for the PSS
- ◆ The winner must conduct a CPD activity, demonstrating his / her expertise to fellow pharmacists within a year of award.
- ◆ The winner may not be nominated again for the next two consecutive years

### **PRESENTATION OF AWARD**

The winner will be announced at a presentation ceremony in conjunction with the 19<sup>th</sup> Singapore Pharmacy Congress in October this year. The winner will receive S\$1,000 in cash, free PSS membership for 1 year and a plaque.
