Community Chapter

- to improve the professional standards of community pharmacy.
- to encourage the delivery of pharmaceutical service to the community.
- to advise the Council on issues facing community practice and present the community perspective in the healthcare scene.
- to promote communication between pharmacists in the community and other areas of practice
- to promote continuing education and professional training relevant to the needs of pharmacists and pharmacy assistants in the community.

Hospital Chapter

- to promote communication between pharmacists working in the hospital environment
- to promote integration between pharmacists working in the hospital environment and those involved in the other areas of pharmacy practice
- to encourage and promote continuing education and other professional training which are relevant to the pharmacists practising in the hospital environment
- to advice the sitting PSS council on matters and issues pertaining to the hospital environment

Industry Chapter

- to promote better integration and communication between pharmacists in the industry and other branches of the profession
- to advise the Council on issues facing pharmacy in industry and present the industry perspective in the healthcare scene
- to foster and develop the roles and functions of pharmacists/pharmacy graduates working in various capacities in the industry
- to promote pharmaceutical education and professional training relevant to the needs of pharmacists in the industry

Education Committee (Professional Education)

- to provide continuing pharmaceutical education to pharmacists, thereby raising professional standards
- to develop and expand up-to-date, relevant continuing education programmes
- to provide pre-registration training
- to organise relevant courses and accreditation programmes for pharmacy staff

Education Committee (Public Education)

- to empower members of the public with appropriate information to make informed decisions about their own health management
- to further heighten pharmacists' role in health system through:
 - (i) Promotion of health awareness and well-being
 - (ii) Disease prevention and health promotion
 - (iii) Identification of ill health
- To promote and encourage the public to practice safe and effective self-care:
 - (i) Self medication for minor ailments
 - (ii) Empower patients/public to participate in their well-being, disease prevention and management
